SEMA sponsorships:

- 1. Gold Sponsorship: There will be a total of 25 gold sponsorships available. A Gold sponsorship will be worth up to \$500 (depending on what is being powder coated on your build). Important note: You are able to use your sponsorship for multiple builds.
- 2. Silver Discount Sponsorship: If you are not selected as a Gold Sponsor, don't worry! We will be able to offer you 200 lb. pricing on all of your powder for your SEMA build. Please keep in mind that you will still need to submit your rendering and application in order to be considered for the "Silver Discount Sponsorship". Prismatic Powders will not provide any additional credits for this level of sponsorship.

IMPORTANT NOTE: YOU MUST SUBMIT YOUR SPONSORSHIP REQUEST BY AUGUST 1<sup>ST</sup> OF THE CURRENT YEAR TO BE CONSIDERED!

Prismatic Powders specific guidelines are required for any level of sponsorship and they are outlined below:

- 1) All sponsorships will be required to pay for all powder when placing the orders with Prismatic Powders.
- 2) Prismatic Powders will provide you with a credit for the powders used on the build once all of the guidelines are met.
- 3) A professional rendering of the vehicle to be considered for sponsorship approval.
- 4) Prismatic Powders will be tagged via Facebook, Instagram and any other social media formats for shows attended. (#PrismaticPowders/@PrismaticPowders)
- 5) A complete list of vehicle components and parts to be coated, must be submitted with color(s) for components in order to determine the correct amount of powder for sponsorship.
- 6) The sponsored party must identify the location of the build at the show that they are attending. Including; booth number, building number and anything else that might be pertinent in helping find your project. This will allow us to call out each build through our social media platform.
- 7) The powder coating applicator must be a Prismatic Powders Qualified Applicator on the Applicator Map <u>https://www.prismaticpowders.com/resource/locator/.</u> You must discuss all application questions prior to powder coating the components or parts. Prismatic Powders will not replace powders that have been applied improperly and/or not in accordance with our application recommendations.
- 8) If there is a need of additional powder for the project, Prismatic Powders reserves the right to change the sponsorship for the powder, if the request is determined to be in excess of what is determined to be needed.
- 9) Prismatic Powders will provide the powder coating only for approved sponsorships at the approved level as outlined above.
- 10) Once the approved show has been completed, you must submit the professional photos of the project in the show displaying the powder application, as well as the Prismatic Logo's.
- 11) Prismatic Powders requires a list of all shows that will be attended, and a photo of the vehicle at the show must be posted as proof of attendance.
